



## COVID-19 Special Camp Participation Informed Consent

Participation in Special Camp programs could put participants at a higher risk of exposure to the COVID-19 virus. In order to participate in this program, participants and parents are required to read and sign the following informed consent and waiver.

I understand and accept that:

1. the COVID-19 virus is highly contagious and has been declared a worldwide pandemic by the World Health Organization.
2. children with underlying medical conditions are at increased risk for severe illness from COVID-19.
3. an individual participating in the program and utilizing the facilities associated with them can be at a higher risk of exposure to the COVID-19 virus.
4. by participating in the program and utilizing the facilities associated with them, an individual may transmit the virus to others, including those they have contact with outside the program setting.
5. while every attempt is made by Special Camp and St. Margaret's Episcopal School to minimize chances of exposure, no guarantees can be made.

To do my part in limiting the exposure and/or transmission of COVID-19 to myself and those around me, I, the participant, agree to follow the St. Margaret's COVID-19 protocols established by Special Camp and the CDC guidelines that include:

- Proper hygiene and handwashing.
- Maintain physical distancing.
- Minimize equipment sharing, and clean and disinfect shared equipment between uses by different people.
- Face coverings (masks or shields with a drape (no gaiters)) are required at all times, except when eating, drink, or swimming.
- No sharing of drink bottles, food, and other personal items or equipment.
- Participation in St. Margaret's COVID-19 surveillance testing if requested.
- Daily self-monitoring of symptoms.
- Immediate disclosure to Special Camp of symptoms, exposure, high risk activities, or positive COVID-19 test.
